

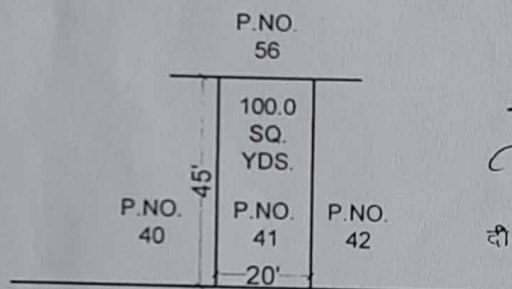
SITE PLAN OF PLOT NO. 41 IN
