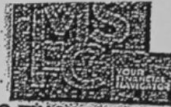

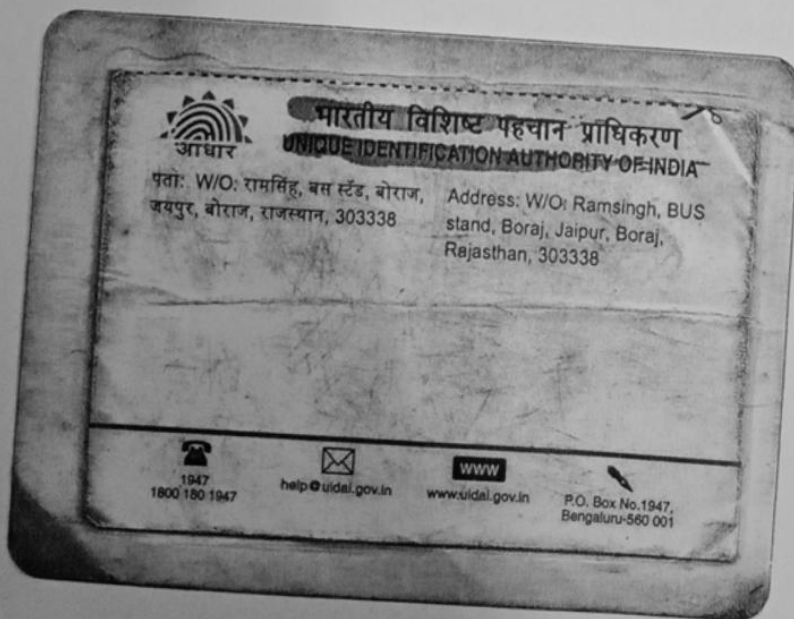

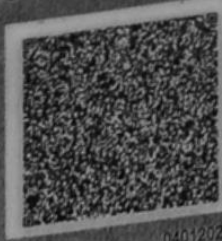

AT BORAJ NEAR MEGHA HIGHWAY MAHALA TO JOBNER ROAD, JAIPUR

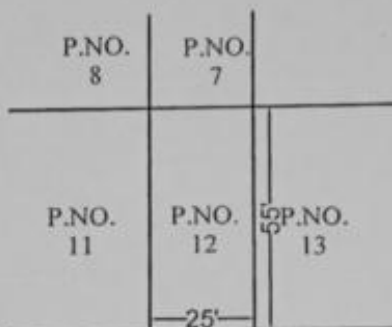
